All providers meet the Department of Defense, Air Force and SJAFB requirements. All providers are monitored and observed at least monthly to ensure compliance with fire, safety, health, and developmentally appropriate practices.

All providers residing on the installation are certified by the Mission Support Group Commander to provide child care in their homes. Affiliated providers residing off the installation must receive North Carolina state licensing prior to receiving affiliation by the Mission Support Group Commander.

#### **REQUIREMENTS**

- Must be 18 years of age
- Have the ability to read, write and speak English
- Possess a high school diploma or equivalent
- Be physically and mentally capable of providing child care

#### **OBTAINING A CERTIFICATION**

- Complete the provider application and return it to the FCC Office
- Consent to local and federal background checks
- Participate in a family interview
- Accomplish orientation training
- Obtain a current physical and all required immunizations
- Attain a copy of your driving record
- Secure liability insurance
- Set up home environment and agree to home inspections by the SJAFB Fire Department, Public Health, Safety Office, FCC Office and CYS Flight Chief

Please note: Individuals with chronic health concerns, including those who are HIV-positive, may be approved as FCC providers.

#### **UNAUTHORIZED CHILD CARE**

It's in violation of AFI 34-144, Child and Youth Programs, for anyone residing in base privatized housing to provide child care services on a regular basis for 10 or more hours per week.
