Each active or retired member of the U.S. military, including the National Guard, Reservists, the U.S. Coast Guard, the U.S. Space Force, the Commissioned Corps of the Public Health Service (PHS) and the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA), or his/her spouse may purchase no more than six (6) Disney Military Salute Tickets. Valid military ID required for all ticket transactions and military member (or spouse) must accompany the persons using these tickets for Theme Park admission. May not be combined with other discounts or promotions. All tickets and options are nontransferable, nonrefundable and exclude activities/events separately priced.

- Eligible Service Members (or their spouse) must present valid military identification to purchase 4-, 5-, or 6-Day Disney Military Salute Tickets.
- Disney Military Salute Tickets may be purchased at participating U.S. military sales outlets ONLY by Eligible Service Members or their spouse (but not both), for use by themselves and other family members and friends.
- No more than six (6) Disney Military Salute Tickets may be purchased by any Eligible Service Member or their spouse during the period of Oct. 24, 2023 – Dec. 17, 2024 (regardless of the place of purchase and whether purchased by an Eligible Service Member or their spouse). In addition, the Eligible Service Member or their spouse must use one of the six (6) Disney Military Salute Tickets purchased.
- Each Disney Military Salute Ticket must be used by the same person on any and all days.
- Tickets may be purchased through Dec. 15, 2024, in the case of the 6-Day Disney Military Salute Ticket; Dec. 16, 2024, in the case of the 5-Day Disney Military Salute Ticket; and Dec. 17, 2024, in the case of the 4-Day Disney Military Salute Ticket.
- Tickets may be used Jan. 1 – March 23, April 27 – Nov. 23, and Dec. 1-20, 2024.
- Tickets and options expire and may not be used after Dec. 20, 2024 (and, accordingly, Military Salute Exchange Certificates may not be exchanged for tickets after Dec. 20, 2024).
- All tickets and options are nontransferable and nonrefundable, and exclude activities/events separately priced.
- May not be combined with other discounts or promotions.

TERMS AND CONDITIONS

Please review the following Terms and Conditions prior to submitting your 2023 Disney Military Salute Ticket Request Form. ALL TICKET SALES ARE NON-REFUNDABLE AND NON-TRANSFERABLE.

- Up to six tickets may be purchased per year only by Eligible Service Members OR their spouses (**but not both**), for use by themselves and up to 5 guests.
- **No more than six (6) Disney Military Salute Tickets may be purchased by any Eligible Service Member or spouse** (regardless of the place of purchase and whether purchased by that person or that person's spouse).
- **ALL Tickets, including the Eligible Service Member's ticket, MUST be purchased in the same transaction.** Additional transactions will not be authorized.
- One of the six tickets purchased must be used and activated by the Eligible Service Member or his/her spouse at Disney World theme park ticket windows. Eligible Service Member must present their DOD ID Card at the Disney World theme park ticket window for activation. Each ticket must be used by the same person on any and all days.
- **Tickets must be activated at a ticket gate between January 1, 2024 through December 15, 2024.** ALL Disney Military Salute Tickets expire and may not be used after December 20, 2024.
- **BLOCKOUT DATES APPLY!** Military Salute Tickets may not be used on the following dates: March 24- April 6 2024; November 24-30 2024.
- **ALL TICKET SALES ARE NON-REFUNDABLE AND NON-TRANSFERABLE**
- **All Tickets that include the Park Hopper® Option or the Park Hopper® Plus Option and any other Tickets that allow the holder to visit more than one of the Theme Parks on the same day are subject to the following limitations:**
 - A Ticket cannot be used for a second, third or fourth Theme Park on the same day prior to 2 p.m.
 - The ability to visit a park is subject to the park's capacity limitations. A park reservation is only required for the first Theme Park on each day, but reservation requirements are subject to change by us in our sole and absolute discretion.
