#### Section 1 - GAME RULES & QUALIFICATIONS

**1.1** These rules for the Scratch-off Game are comprised of: (1) the "Working Papers" for the Seymour Johnson Air Force Charge 4<sup>th</sup> Games which establishes the game specifications and parameters; (2) the material presented in these Scratch-off Game Rules; (3) online at www.sjfss.com, Facebook (sjfss), and Instagram (4sjfss); and (4) any practices or procedures utilized by FSS/FSK. For the Card Holder Complaint Procedure, please email <u>UDG 4FSS MARKETING@us.af.mil</u>. The items cited herein are incorporated by reference and are binding as if printed herein. Each document cited above shall have equal weight unless there is an inconsistency between or among these documents in which case the document listed first shall be controlling.

**1.2** These rules become effective on the date the initial game allocation of cards is sent from FSS Marketing Department to FSS facilities and events (July 23<sup>rd</sup>, 2021), and will remain effective through September 30<sup>th</sup>, 2021 to claim an instant prize for this Scratch-off Game. For end of game procedures visit the Scratch-off Game Page at <u>www.sjfss.com</u>.

**1.3** To determine if the "Last Day to Receive Cards" in a FSS Facility and/or event has been established for this game visit the Scratch-Off Game Page at www.sjfss.com or visit the Facebook event page at SJFSS.

**1.4** Charge 4<sup>th</sup> Games cards shall be made available at the discretion of the Marketing Director & FSS Leadership.

#### 1.6 How to Play

- **A.** Receive Charge 4<sup>th</sup> Scratch-off Cards:
  - Charge 4<sup>th</sup> Scratch-off Cards will be handed out through different avenues by FSS leadership and FSS Staff.
  - Scratch-off Cards will be handed out at select FSS events and FSS facilities through to the timeframe of July 23<sup>rd</sup>, 2021 to August 13<sup>th</sup>, 2021.
  - By staying engaged with 4 FSS social media accounts: Facebook and Instagram, you will get the most current information on distribution locations and events.

- B. Gather Cards
  - There are only three hundred (300) valid Charge 4<sup>th</sup> Scratch-off cards that are eligible for entry into the Golf Cart Drawing.
  - A valid entry into the Golf Cart Drawing will specifically say "WINNER ENTRY." Winning cards have one scratch-off area with this exact verbiage.
  - There will be other winning cards for other prizes. Information on these can be found in section 2.
- **C.** Golf Cart Drawing
  - All of the valid physical Charge 4<sup>th</sup> Drawing Scratch-off cards will need to be filled out and submitted to the Marketing tent/area at the Wing Cook Off event on August 13<sup>th</sup>, 2021 at the Mustang Taproom, SJAFB from 4:00 pm to 6:00 pm.
  - All of the valid digital Charge 4<sup>th</sup> Drawing Scratch-off cards will need to be claimed by emailing <u>UDG 4FSS MARKETING@us.af.mil</u> no later than August 12<sup>th</sup>, 2021 at 4:00 pm. Digital Scratch-Off cards can also be claimed in person, filled out and submitted to the Marketing tent/area at the Wing Cook Off event on August 13<sup>th</sup>, 2021 at the Mustang Taproom, SJAFB from 4:00 pm to 6:00 pm.
  - Any participant that submits their golf cart entry card must be present at the time of the drawing in order to have a chance to win.
  - There will be ten (10) valid golf cart drawing entries picked at random from the winning golf cart entry tickets.
  - As each participant validates and claims their card each will pick one (1) of ten (10) envelopes that hold a combination code. One (1) combination code will be able to unlock the master lock placed on the golf cart and the other nine (9) will be invalid combination codes.
  - After the ten participants choose their envelopes all of the remaining golf cart drawing entries and losing second chance cards will be mixed together for the other prize drawings.
  - Once all other prizes are claimed it will then be time for the participants with the combination codes to attempt to unlock the master lock with their chosen code.

#### Section 2 – DEFINITIONS

**2.1** "Low Tier Prize" is a prize of \$19.00 and less. All other prizes are mid- to high-tier prizes.

**2.2** "Card" is a SJAFB Charge 4<sup>th</sup> card.

**2.3** "Card Validation Code" for the Charge 4<sup>th</sup> Scratch-Off is the unique number printed in the play area on the front of the Card underneath the removable, rub-off covering made of opaque elastomeric material and overprint. \*Winning golf cart entries do not have this specific numerical code, only instant winning cards.

**2.4** "Icon Symbols" are one of the symbols which appear under the one spot on the front of the card marked "Your Icons" and/or "Winning Icons". Paragraph 2.5, 2.6 and 2.7 illustrates the possible Play Icon Symbols used.

2.5 Prize Icons will be as shown below



**2.6** "Validation Code" consists of two (2) small codes found under the removable scratch off coating under the Play Icon Symbols on the front of the card, which FSS/FSK and its facilities use to verify and validate winners. For CHARGE 4<sup>th</sup> Games the Validation Codes are: a GOLF CART ICON with WINNER ENTRY stated for Golf Cart Drawing winners. For other sponsored prizes are: a PRIZE ICON with WINNER stated along with prize details, and GLAC code beneath the removable scratch off coating.

**2.7** A "Non-Winning Card" is defined as a CHARGE 4<sup>th</sup> Games card which does not state WINNER underneath the removable scratch off coating.

## Section 3 - DETERMINATION OF INSTANT PRIZE WINNERS

**3.1** The following subparagraphs specify how a prizewinner of an instant prize is determined in the CHARGE 4<sup>th</sup> Games scratch off game.

The entire circle play area on the front of the scratch off card is to be rubbed off to determine the Icon Symbol. If the card specifically states WINNER, the card holder will win the prize stated. If the card holder gets a "GOLF CART" Icon Symbol with the statement "WINNER ENTRY", the card holder will win an automatic entry into the Golf Cart drawing instantly at the Wing Cook Off/Closing Ceremonies Event on August 13<sup>th</sup>, 2021 at Eagles Landing, SJAFB from 4:00pm to 6:00pm.

**3.2** No portion of the Point of Purchase (POS) material(s) which display printing of this Scratchoff Game or any extraneous matter whatever shall be usable or playable as a part of the Scratch-off.

**3.3** Determination of prize winners shall be subject to the instant Card Validation Requirements set forth in Section Five (5) of these Rules and any other validation requirements utilized by the Charge 4<sup>th</sup> Games.

**3.4** The GLAC Code (including any portion thereof) is not a Play Icon or Prize Icon Symbol and cannot be used as a Play or Prize Icon Symbol.

## THE ODDS AND TOTAL NUMBER OF PRIZES ARE BASED UPON THE CARDS ORDERED (5,000) AND NOT THE QUANTITY OF CARDS ACTUALLY DELIVERED TO EACH FSS FACILITY AND/OR EVENT.

The prizes listed above are distributed randomly throughout all of the cards ordered as governed by the programming parameters established by Charge 4<sup>th</sup> Games. Reorders, if any, will affect odds, total number of prizes, and the total value of prizes available. #### Section 5 – SCRATCH OFF CARD VALIDATION REQUIREMENTS

**5.1** To be a valid Physical Scratch-off Card, all of the following requirements must be met:

- A. The scratch-off cards must reveal exactly one icon stating "WINNER". The revealed icon will REVEAL and STATE what prize has been won or state "SORRY, NOT A WINNING CARD".
- B. Each of the scratch-off areas and must be revealed in its entirety and be fully legible.
- C. The Card shall be intact. The FSK Marketing Department, or designee, shall determine whether a card is intact and the FSK Marketing Director, in his or her sole discretion, may affirm or deny the FSS Marketing Department determination.
- D. The Card GLAC Code must be present in its entirety and be fully legible. The Card GLAC code shall correspond, using Charge 4<sup>th</sup> Games' codes, to the Prize Icon Symbols on the Card.
- E. The Card must not be mutilated, altered, unreadable, reconstituted, or tampered with in any manner.
- F. The Card must not be counterfeit in whole or in part.
- G. The Card must have been issued by FSS in an authorized manner. The Card will have been received from an official FSS staff member and, subject to the provisions of Section 6, presented by the proper holder for validation.
- H. The Card must not be stolen nor appear on any list of omitted Cards on file at FSS Marketing.
- I. The Prize Icon Symbols, and Card Validation Number must be right side up and not reversed in any manner.
- J. The Card must be complete, and not miscut, and have one icon that state's "WINNER" on the front of the Card in relation to the cards winning directions.
- K. The Card must not be blank or partially blank, misregistered, defective or printed or produced in error.
- L. Each of the twenty (20) Prize Icon Symbols must be exactly one of those described in paragraphs 2.4, 2.5, 2.6, and 2.7.
- M. All symbols and codes must appear in the proper font and correspond to the artwork on file at FSK.

- N. The display printing must be regular in every respect and correspond precisely with the artwork on file at FSK and contained in the working papers for this scratch-off game.
- O. The Card must pass all additional validation tests provided for in the Rules of the Charge 4<sup>th</sup> Games and confidential validation tests of FSK.
- **5.2** To be a valid Digital Scratch-off Card, all of the following requirements must be met:
  - A. The scratch-off card screenshot must reveal exactly one icon stating "WINNER". The revealed icon will REVEAL and STATE what prize has been won or state "SORRY, NOT A WINNING CARD".
  - B. Each of the scratch-off areas must be revealed in its entirety and be fully legible.
  - C. The screenshot of the card shall be intact. The FSK Marketing Department, or designee, shall determine whether a card is intact and the FSK Marketing Director, in his or her sole discretion, may affirm or deny the FSS Marketing Department determination.
  - D. The GLAC Code must be present in its entirety in the screenshot and be fully legible. The GLAC code shall correspond, using Charge 4<sup>th</sup> Games' codes, to the Prize Icon Symbols on the Card.
  - E. The screenshot of the card must not be mutilated, altered, unreadable, reconstituted, or tampered with in any manner.
  - F. The screenshot of the card must not be counterfeit in whole or in part.
  - G. The screenshot of the card must have been issued by FSS in an authorized manner. The screenshot of the card will have been received from an official FSS staff member and, subject to the provisions of Section 6, presented by the proper holder for validation.
  - H. The screenshot of the card must not be stolen nor appear on any list of omitted Cards on file at FSS Marketing.
  - I. The Prize Icon Symbols, and Card Validation Number must be right side up and not reversed in any manner.
  - J. The screenshot of the card must be complete, and not cut off, and have one icon that state's "WINNER" on the front of the screenshot in relation to the digital cards' winning directions.
  - K. The screenshot of the card must not be blank or partially blank, misregistered, defective or printed or produced in error.
  - L. Each of the twenty (20) Prize Icon Symbols must be exactly one of those described in paragraphs 2.4, 2.5, 2.6, and 2.7.
  - M. All symbols and codes must appear in the proper font and correspond to the artwork on file at FSK.
  - N. The display printing must be regular in every respect and correspond precisely with the artwork on file at FSK and contained in the working papers for this scratch-off game.
  - O. The screenshot of the card must pass all additional validation tests provided for in the Rules of the Charge 4<sup>th</sup> Games and confidential validation tests of FSK.

**5.3** A screenshot which fails any of the Charge 4<sup>th</sup> Games' validation checks is invalid and ineligible for any prize. The Marketing Director may replace an invalid digital card with an unplayed digital card from the same game. If a defective screenshot is received, the only responsibility or liability of the Marketing Director and/or Leadership shall be the replacement of the defective digital card with an unplayed digital card from the same game. Whereas this is subject to situation and availability.

#### Section 6 - INSTANT CARD CLAIM PERIOD AND CARD RESPONSIBILITY

**6.1** All winning golf cart game cards must be claimed at the Wing Cook Off Event on August 13<sup>th</sup>, 2021 at the Mustang Taproom, SJAFB from 4:00 pm to 6:00 pm. All instant prizes must be claimed by September 30<sup>th</sup>, 2021 unless otherwise noted.

**6.2** All winning digital golf cart game cards must be claimed by submitting a screenshot of the winning screen by emailing <u>UDG 4FSS MARKETING@us.af.mil</u> and including participant's name, home address, email address, sponsor name, and phone number. Upon validation, winner's information will be added to a database. Winner's name will be added to the pool of other winners at the Wing Cook Off Event on August 13<sup>th</sup>, 2021 at the Mustang Taproom, SJAFB from 4:00 pm to 6:00 pm. All instant prizes must be claimed by September 30<sup>th</sup>, 2021 unless otherwise noted by submitting a screenshot of the winning screen by submitting a screenshot of the winning screen by emailing <u>UDG 4FSS MARKETING@us.af.mil</u> and including participant's name, home address, email address, sponsor name, and phone number. Upon validation, winner will then be given instructions on how to claim their prize.

**6.3** An instant game Card is a bearer instrument until signed on the back by the owner.

**6.4** FSK and/or its facilities shall not be responsible for lost or stolen Cards.

**6.5** FSK shall not be responsible for Cards that are lost or not submitted at the date of the Wing Cook Off event (August 13<sup>th</sup>, 2021 at the Mustang Taproom, SJAFB from 4:00 pm to 6:00 pm).

**6.6** FSK shall not be responsible for Cards claimed by a player in error for a lower prize at a FSS Facility and/or other sponsor location.

#### Section 7 – DISPUTES

In the event a dispute between FSS Facilities and the card bearer occurs as to whether the Card is a winning card, and if the Card prize is not paid, the Marketing Director and/or Leadership may, solely at his or her option, replace the disputed Card with an unplayed Card. This shall be the sole and exclusive remedy of the bearer of the Card. For the Card Holder Complaint Procedure please email <u>UDG 4FSS MARKETING@us.af.mil</u>.

#### Section 8 - TERMINATION OF THE GAME

The Marketing Director and/or Leadership may at any time, and in his or her sole discretion, stop distribution of cards.

#### Section 9 - PRICE OF CARD

**9.1** The price of a scratch-off card is the amount of \$0.00 USD.

**9.2** None of the scratch-off cards are redeemable for any cash value.

**9.3** No cash value will be awarded in lieu of the golf cart as a prize.

#### Section 10 – REDEEMING PRIZES

**10.1** Winners must be present to win the grand prize and any other itemized prizes.

**10.2** Winner will be notified at the time of award of any liability incurred by winning (i.e. and tax liability, etc.) and has the option to decline the prize. Prize/golf cart will be awarded to the next winner as determined at that time.

**10.3** All scratch off prizes will be claimed/redeemed in the following manner:
