- Up to six tickets may be purchased per year only by Eligible Service Members and their spouses, for use by themselves and up to 5 guests. **No more than six (6) Universal Orlando Freedom Passes may be purchased by any Eligible Service Member and spouse (regardless of the place of purchase)**
- Tickets, including the Eligible Service Member's ticket, MUST be purchased in the same transaction. **Additional transactions will not be authorized.**
- Tickets may not be transferred, distributed or resold.
- One of the six tickets purchased must be used and activated by the Eligible Service Member. **Eligible Service Member must present their DOD ID Card at the Universal Studios Orlando theme park ticket window for activation.** Each ticket must be used by the same person on any and all days. Adult ticket holders will be required to present a valid photo ID with their ticket at the time of activation at Universal Studios Orlando.
- Tickets may be used November 14, 2024 through December 19, 2025. **ALL Universal Studios Orlando Freedom Passes expire and may not be used after December 19, 2025.**
- **Blockout Dates Apply - 12/25/2024 - 1/2/2025 and 4/14/2025 - 4/20/2025**
